

# CAMPBELLSVILLE UNIVERSITY MERIT Scholarships

## What is a merit scholarship?

Merit scholarships are a type of institutional aid that is awarded to every student that meets our minimum requirements for acceptance. Merit scholarships are determined by evaluating each student's cumulative GPA at the time of acceptance.

Merit Scholarships	Award	GPA
Trustees	\$15,500	3.90 and higher
Provost	\$14,500	3.60 - 3.89
Dean	\$13,500	3.0 - 3.59

## How do I apply for a merit scholarship?

When a student fills out an application for admission and submits the necessary documents for acceptance, they are automatically considered for a merit scholarship. No further application is needed.

3.0+ GPS's are awarded merit scholarships automatically.

## Are merit scholarships renewable?

Yes, all merit scholarships are renewable for three years as long as a student meets the Campbellsville Office of Financial Aid Satisfactory Academic Progress Policy.

## Is there a deadline to receive the merit scholarship?

There is no deadline as merit scholarships are awarded at the time a student is accepted.

## Does Campbellsville University use weighted GPAs when calculating merit scholarships?

Yes, if a student submits a transcript that lists a weighted GPA scale, the weighted GPA will be used to evaluate a student's merit scholarship. If no weighted GPA is provided on the transcript, the standard 4.0 GPA scale will be used.

## How can I find out what my merit scholarship will be?

Once the amounts for merit scholarships have been determined (usually during the fall semester), students will be told their merit scholarship amount. Students can contact their admissions counselor if they have any questions regarding their scholarship.

## TRANSFER MERIT Scholarships

### What is a transfer merit scholarship?

Transfer merit scholarships are a type of institutional aid awarded to transfer students meeting minimum requirements for acceptance. Transfer merit scholarships are determined by evaluating each student's cumulative GPA of any previously attended institutions.

*\*If the transfer student has earned less than 24 hours, they must also supply a high school transcript before scholarships can be awarded.*

Award	GPA
\$12,000	3.5 and higher
\$10,000	2.5 - 3.499
\$9,000	2.0 - 2.499

### How do I apply for a transfer scholarship?

When a student fills out an application for admission and submits the necessary documents for acceptance, they are automatically considered for a merit scholarship. No further application is needed.

### Are transfer scholarships renewable?

Yes, all transfer scholarships are renewable for three years as long as a student meets the Campbellsville Office of Financial Aid Satisfactory Progress Policy.

### Is there a deadline to receive the merit scholarship?

There is no deadline as transfer scholarships are awarded at the time a student is accepted.

### How can I find out what my transfer scholarship will be?
