# MUS 321 History of Music I Fall Semester 2016 TR 11:00 a.m. – 12:15 p.m. – GC 202

#### **Description of Course**

A study of the history of music in Western cultures beginning with the rise of West Asian and East Mediterranean music and extending to the end of the Baroque. The course is designed to establish a working knowledge of the development of musical styles and their historical importance.

#### **Course Objectives**

By the end of the course, students should be able to:

- Gain a working knowledge of the development of musical styles and traditions within the context of historical and anthropological conditions.
- Name major composers of musical development in Western cultures and interpret their influence upon contemporaneous composers as well as those of future generations.
- Develop a listening skill for identifying many of the styles from the earliest known times through the Baroque and enjoy the experience of listening to challenging music.
- Increase confidence in speaking and writing about music with coherent ideas in class discussions and written assignments.
- Appreciate music as a gift from God and recognize human creativity shaping and influencing the formation of musical development, especially that of church music.

- viii. **Listening Quizzes.** Listening to music is greatly emphasized in this course. There will be six listening quizzes, two per unit. Please see class schedule below.
- ix. Written Exams. Three written exams over classroom lectures and textbook readings. Please see Class Schedule below.
