The Impact of Campbellsville Trips

This study examined the impact of Campbellsville University faculty led trips on faculty, staff, and undergraduate students. Examining the impact of school-sponsored trips, allows faculty and administrative leaders to use and translate research evidence to inform and improve the development of school-sponsored trips.

2013-2014 Employment Sustainability of Campbellsville Graduates in Child Welfare

This study examined the ability of Campbellsville University's Carver School of Social Work to prepare graduates for employment in the child welfare field through qualitative interviews. Researchers examined what factors graduates contributed to their leaving child welfare and how the program could be improved to minimize these factors.

2009-2014 Transitioning a BSW Program's Assessment Plan from Learning Outcomes to Competencies

The CSWE self-study process for reaffirmation of accreditation of the BSW program led to more intentional and focused teaching of competencies across the curriculum. Ongoing research examines the student outcomes and makes program changes as indicated by the research.

2007-2010 Infusing Geriatric Education Across the BSW Curriculum

This research examined the effectiveness of infusing geriatric across the BSW curriculum. A Geriatric curriculum development grant by the Hartford Foundation supported this research.

2004-2005 Domestic Violence and Child Repeat Maltreatment

This study examined 121 closed child protective service cases to answer the research question, "What is the relationship between repeat child maltreatment and domestic violence?"

1999-2001 Students' Evaluation of Field Placements

This study analyzed student responses on field placement surveys at the Kent School of Social Work. Content analysis was used to identify major strengths and limitations of the field placement program.

1997-1998 Child Protection Casework Effectiveness

This pilot project provided workers with a measurement tool to evaluate casework effectiveness in protective service cases. Practitioners utilizing a single subject design evaluated their casework effectiveness in 102 protective service cases over a two-year period.
